1. Product Description

The DXS Point-of-Care[™] product is a content aggregator, which integrates with Electronic Patient Record (EPR) software, ensuring a prime position on the healthcare professional's desktop. This allows content providers to have a direct channel to the healthcare provider during the patient consultations. The DXS product enriches the content with its own relationship-linking process, part of which incorporates the appropriate country-specific diagnostic coding system.

The diagnosis is entered into the EPR and information in DXS Point-of-Care[™] relating to that diagnosis is automatically populated for the healthcare provider. The healthcare provider is presented with the specific information related to the patient he or she is consulting, without having to search different databases, which expedites the review.

The DXS Point-of-Care[™] product contains clinical data on diseases and procedures as well as patient information on drugs and diseases.

5.1 Introduction

Version 5.7.9 is a maintenance release that brings enhancements to our Forms functionality along with several fixes throughout the product.

5.2 Enhancements

- 1. 4792 Added the ability to disable all draft exports (previously for Save to Patient Record).
- 2. 6806 Added the ability for email settings to override for Admin users (PRB-128003).
- 3. 8099 A new prompt has been added to distinguish removing a draft from other forms.
- 4. 8520 Heartbeat now supports HTTPS.
- 5. 8599 TPP Device ID now included in the Heartbeat report.
- 6. 9280 Search fields can now contain all relevant data when specifying 99 years back.
- 7. 9281 Patient records with Reasonable Adjustments are now flagged when opened.
- 8. 9313 Search fields can now have their descriptions split from the data/value, aiding validation on the field.
- 9. 9319 Search fields can now have their data value and unit of measure split, aiding automatic readers.
- 10. 9633 Added the ability to validate on months in Date fields.
- 11. 9647 Prompt for Smartcard details now include a check for active e-RS subscription and a Clinical Role.

6.1 Introduction

Version 5.7.5 introduces two key features: Live Chat integration for DXS support and the capability to submit to the live e-RS environment. Additionally, this version includes several important fixes, such as search fields not populating the latest blood results, inactive 'Email' and 'Print' buttons, and the 'Notes' pane obscuring forms.

6.2 Enhancements

- 1. 3CX Live Chat Support has been implemented and enabled per locality.
- 2. We can now connect to the live e-RS environment.
- 3. When clicking on a field with a long numeric decimal value, the full value is shown.
